Alagappa University, Plot/Khasara No. 540, 541/2, 544, Karaikudi Village, Alagappapuram Post, Sivaganga District, Pin 630003, Tamil Nadu for B.Ed-ODL Programme was granted by NCTE with following details:-

- The SRC vide Order No. F.No.SRCAPP1824/B.Ed.DE/TN/2013-14/57387 dated 03.03.2014 to offer B.Ed. ODL course of two years duration from the academic session 2014-2015 with an annual intake of 500 students.

The matter regarding consideration of B.Ed. (ODL) programme was remained under consideration of the SRC from time to time. The case has also been placed before 434th meeting of SRC-NCTE held on 22nd March, 2024 and the SRC decided the following:-

"After perusal of the documents submitted by the Alagappa University including to the UGC- DEB approval granted to **Alagappa University** to conduct the B.Ed (ODL) Programme only for one academic session January - February, 2024, the Committee decided to grant recognition to Alagappa University to conduct the B.Ed (ODL) Programme only for one academic session from January - February, 2024 with permitted intake. The University shall ensure the adherence of norms and standards of B.Ed. (ODL) particularly the following before the commencement of the academic session: -

- The approval for Self-Instructional Material from the DEB, UGC.
- To ensure the availability of core staff at the University/Distance Education Centre.

This decision will be communicated to the UGC- DEB for information and its further action. Moreover, the University is instructed to strictly follow the NCTE Norms and Standards for admission process and comply with the other requirements of the NCTE Rules and Regulations from time to time."

In view of the above decision of the SRC, **Alagappa University, Plot/Khasara No. 540, 541/2, 544, Karaikudi Village, Alagappapuram Post, Sivaganga District, Pin 630003, Tamil Nadu** is granted recognition to conduct the B.Ed (ODL) Programme only for one academic session from January - February, 2024 with permitted intake. The University shall ensure the adherence of norms and standards of B.Ed. (ODL) particularly the following before the commencement of the academic session: -
